## BREEDING CONTRACT FOR "O' LENAS PLAYBOY"

This agreement is made and entered into on \_\_\_\_ day of \_\_\_\_\_ 20 \_\_\_\_ between \_\_\_\_\_ (mare owner's name) and Shaw's Performance Horses the owner of the stallion O'Lenas Playboy.

**1. Stallion Service Purchase Price:** Mare owner agrees to pay the Stallion owner the fee of \$1100.00 inc GST. A Booking fee of \$330.00 is due and payable prior to the mare arriving at the stud or prior to semen being collected. This fee is non-refundable but is deducted from the total service fee. The balance of the stallion service fee is due and payable when the Mare is tested positive in foal at 45 days. Failure to pay this amount within 30 days of the account being issued will result in loss of free return. An additional booking fee must be paid for each re-breed conducted after the initial year of service.

**2. Agistment** is in addition to the service. Rates: \$5.50 per day for dry mares and \$6.60 per day for wet mares.

**3.** Any drugs used and all breeding veterinary expenses incurred for the mare is at the mare owner's expense. On stud A.I. costs are incorporated in the service fee.

**4. Artificial Insemination (A.I)** All costs associated with collection and transportation (to nearest airport) of cooled semen is in addition to the service fee. Rates: \$181.50 (inc gst) per collection plus transportation costs. Insemination costs shall be paid by the mare owner. The non-refundable booking fee of \$330 MUST be paid to the Stud prior to collection of any semen.

**5.** Stallion owner is not responsible for lost, delayed or damaged semen and makes no representations or warranties of any kind with respect to any semen furnished hereunder except that it is the stallions.

**6.** The mare must be swabbed and have a recent veterinary certificate of health prior to arriving at stud. Or the mare owner agrees to the Stallion owner having mare examined, cultured and treated if infected, prior to commencement of breeding. These costs are the responsibility of the mare owner. The mare owner also grants permission to the Stallion owner to have a veterinarian treat the mare for anything that would ensure her well being, these costs will be billed to the mare owner. The mare should be drenched prior to arrival and be in good body condition with her feet trimmed. The mare owner must give at least 24 hours notice to the stallion owner of its intention to deliver or collect the mare.

**7. Foaling Out** for pregnant mares is available at \$275.00 (inc gst) per mare. Any veterinary expenses associated with the birth will be billed directly to the mare owner.

**8.** While the mare is in the custody of the stallion owner, the stallion owner shall not be liable for any sickness, disease, injury or death which may be suffered by the mare or its progeny. The stallion owner warrants that all necessary precautions will be taken to ensure the well being of the mare and its progeny.

**9.** If the mare shall be found to be not pregnant then the booking fee will be forfeited, however no further service fee shall be payable but all other monies herein mentioned shall be paid and this agreement shall in all other respects be performed and observed.

**10. Live Foal Guarantee:** If the mare aborts or fails to produce a single living foal that can stand unassisted and nurse in the first 24 hours The Stallion owner will allow Mare owner a return breeding of the mare (or a substitute mare if acceptable to Stallion owner) in the next breeding season only, provided that Mare Owner furnishes a satisfactory certificate issued by a licensed veterinarian attesting to occurrence within thirty (30) days of the date of the occurrence. An additional booking fee, in the amount set fourth within paragraph 1, must be paid for each re-breed conducted after the initial year of service.

**11.** Stallion service certificates will be issued only at the time that all accounts have been settled and paid in full. Failure to pay any outstanding amounts within 30 days of the account being issued will result in loss of free return

**12.** The breeding season shall be concluded at 31<sup>st</sup> December each year. Any breeding past this date must be arranged with and agreed to by the Stallion owner.
